

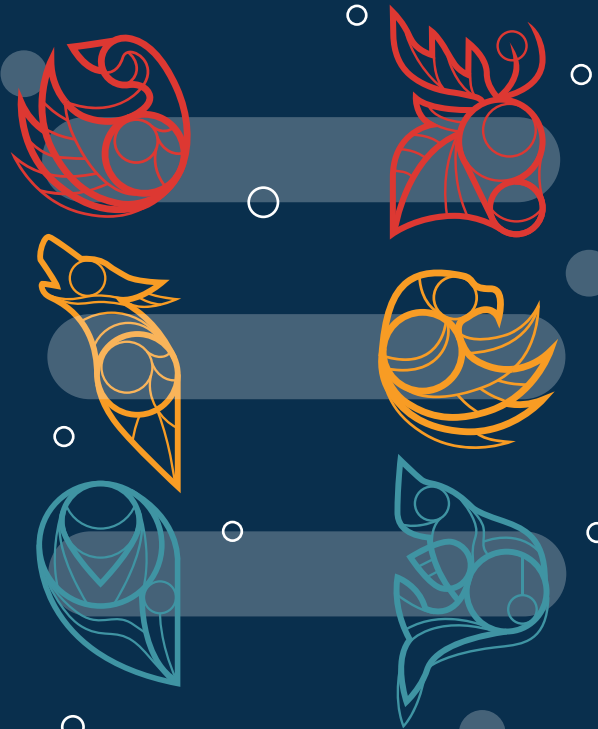
## About

The Introductory Management Accounting course examines how organizations use accounting information to plan, monitor, and control. It ensures students have a basic understanding of how such systems operate, the language they use, and their limitations.

The CPA Western School of Business and the Aboriginal Financial Officers Association of Alberta have collaborated with Indigenous subject matter experts to create an Introductory Management Accounting course tailored to Indigenous learners. The course will be taught by Indigenous instructors and supported by Indigenous facilitators with Indigenous culture and context woven throughout.

The course will be delivered through a combination of community-based real-time, individual, in-person, and remote learning.

## Community-based real-time learning

The community-based real-time learning activities will enable facilitated discussions, create a sense of community within the cohort, and provide opportunities for peer learning and support.

### Hub in-person sessions

At the beginning and end of the course to first create community and then to prepare for the final exam.

### Satellite in-person sessions

Throughout the course to enable learners to work through technical materials, incorporate Indigenous content and context, and hear from guest speakers.

### Student-led webinars

Throughout the course to introduce learners to a variety of topics.

## Individual learning

The individual learning activities will enable flexibility in completing parts of the course so learners can learn at their own pace before the final exam.

Individual learning activities will include a self-paced e-book, quizzes, exercises, and practice problems.

## Final examination

The course will end with a final examination worth 100% of the course grade.

## Entry requirements

To be admitted to the Introductory Management Accounting course for Indigenous learners, applicants must:

- Have 30 credit hours or equivalent
- Have already completed or be concurrently completing Introductory Financial Accounting
- Provide proof of Indigenous Status

Please note that this course is a prerequisite course for entry into the CPA Professional Education Program (PEP). Prior to enrolling in PEP, learners must complete an undergraduate degree in any discipline or be eligible for Mature Entry.
